Particulars on the Account that Payee is authorized to debit are indicated in the “Debit Account Information” section on page 1 of this Agreement. A specimen cheque, if available for the Account, has been marked “VOID” and attached to this Authorization.</p> <p>3. I/We undertake to inform the Payee, in writing, of any change in the Account information provided in this Authorization prior to the next due date of the PAD.</p> <p>4. This Authorization is continuing but may be cancelled at any time upon notice being provided by me/us, either in writing or orally, with proper authorization to verify my/our identity within the specified number of days as noted on Page 1, Cancel Payment section. I/We acknowledge that I/we can obtain a sample cancellation form or further information on my/our right to cancel this Acknowledgement from Processing Institution or by visiting www.cdnpay.ca.</p> <p>I/We acknowledge that if I/we wish to cancel this Authorization or if I/we have any questions or need further information with respect to a PAD, I/we can contact the Payee at the telephone or address set out in this Agreement.</p> <p>5. Revocation of this Authorization does not terminate any contract for goods or services that exists between me/us and the Payee. This Authorization applies only to the method of payment and does not otherwise have any bearing on the contract for goods or services exchanged.</p> <p>6. I/We acknowledge that provision and delivery of this Authorization to the Payee constitutes delivery by me/us to Processing Institution. Any delivery of this Authorization to The Payee constitutes delivery by the Payor.</p> <p>7. I/We acknowledge that Processing Institution is not required to verify that a PAD has been issued in accordance with the particular of this Authorization, including, but not limited to, the amount.</p> <p>8. I/We acknowledge that Processing Institution is not required to verify that any purpose of payment for which the PAD was issued has been fulfilled by Payee as a condition to honouring a PAD issued or caused to be issued by Payee on the Account.</p> | <p>9. I/We acknowledge that this Authorization is for a Personal or Business PAD that has recourse through the clearing system, this PAD maybe disputed under the following conditions:</p> <ul style="list-style-type: none">a. the PAD as not drawn in accordance with this Authorization;b. this Authorization was revoked; orc. pre-notification was required and was not received. <p>I/We further acknowledge that in order to be reimbursed, a declaration to the effect that either a., b., or c. took place must be completed and presented to the branch of Processing Institution holding the Account on or before the 90th calendar day in the case of a funds transfer PAD that has recourse through the clearing system after the date on which the PAD in dispute was posted to the Account.</p> <p>10.
